# What is EB5

- **EB-5 Program:** Introduced by US congress in 1990 to boost the US economy by attracting foreign investors and creating jobs for American workers.
- It is a passive investment program for permanent residency.
- **Investment Requirement:** Investors must invest at least \$800,000 in targeted areas.

The investment must create or preserve 10 full-time jobs for U.S. workers.

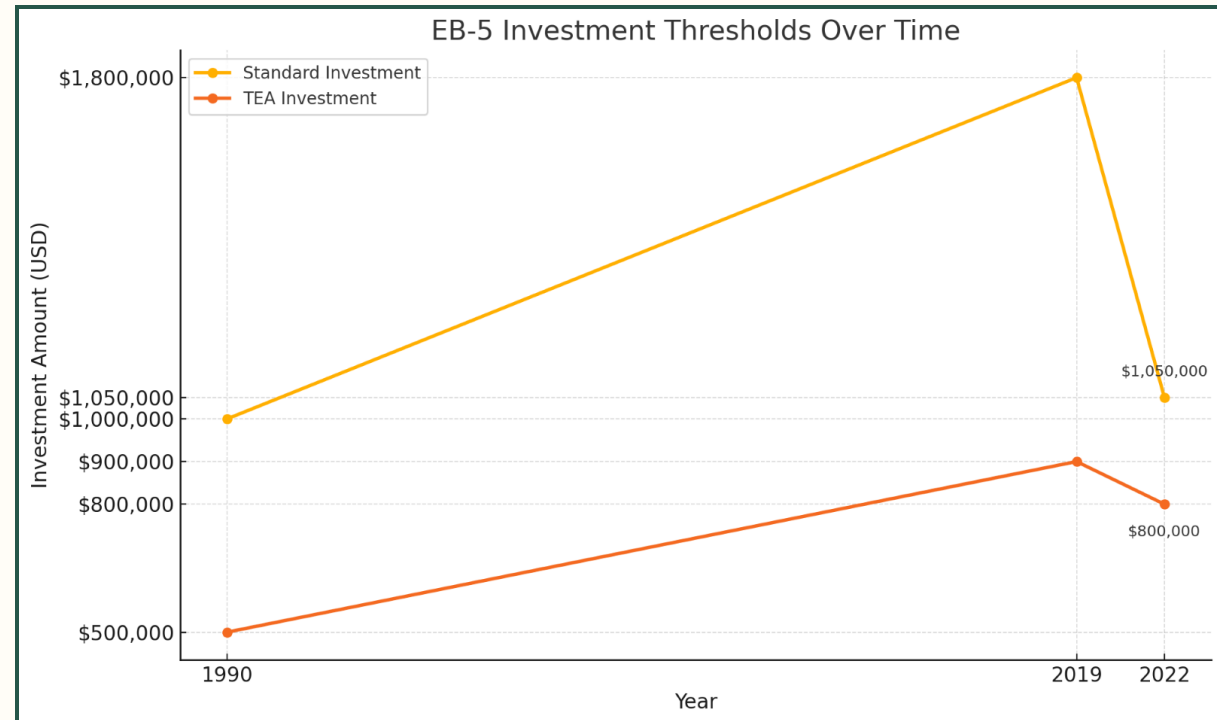
The funds must remain invested for a minimum of 2 years called as sustainment period.

- **Encouraging Investment:** EB5 is the quickest and surest way to get a green card in the US.
- **Path to U.S. Citizenship:** The program offers a way for investors to eventually apply for U.S. citizenship



# EB5 Investment Thresholds Have Evolved

- **Original Investment (Pre-2019):**
  - Targeted Employment Areas (TEAs): \$500,000
- **2019 Increase:**
  - TEAs: \$900,000
- **2022 EB-5 Reform & Integrity Act (Current):**
  - TEAs & Infrastructure Projects: \$800,000 (preferred by most Indian applicants today)

# Process of EB5

## Step 1

### Hire an immigration attorney:

Prepare source of funds with immigration attorney.

## Step 2

### Shortlist project

Select a qualified investment project of \$800,000 in targeted areas.

## Step 3

### Make the Investment:

Transfer the required funds to the chosen U.S. business or project.

## Step 4

### Conditional green card

If approved, you and your family receive a conditional green card for 2 years.

## Step 5

### File I-829 Petition:

After 2 years, submit another petition (I-829) to remove conditions and prove the investment created jobs.

## Step 6

### Permanent Green Card

If approved, you and your family receive permanent U.S. residency (green card).

## Step 7

### Return on Investment (ROI)

After receiving permanent residency, investors can redeem or restructure their investment to recover capital or returns.
